Directions to the Barn (300 Division Lane, Beaver PA 15009)

From Route 60 (Beaver Valley Expressway), take exit #13-B toward Midland; At stop sign, turn right onto Route 68, toward Midland. Take the first right (across from Eighty Four Lumber). At stop sign stay to right – this is Division Lane. At next stop sign, go straight, continuing on Division Lane. The Barn is located approximately 1/8 mile on left side. It is a two story white building that sits very close to the road. Please park along Division Lane, pulling off the road as far as possible. DO NOT PARK IN THE DRIVEWAY.

Directions to Beaver Area High School Pool (Gypsy Glen Road, Beaver, PA 15009)

From Route 60 (Beaver Valley Expressway), take exit #13-A toward Beaver. You will merge onto Route 68. Follow Route 68 to the third red light (Beaver Cemetery is located on the left). At this light, turn left onto Buffalo Street. Go through 1 red light, staying on Buffalo Street, past Beaver outdoor pool and football field. At the end of the fence, turn left, down grade into parking lot. Enter school building through the double doors. As you enter the hallway, the locker room entrances are down the hall to the left.

DO NOT ARRIVE BEFORE 7:30 PM FOR A SWIM TEST!
